Count One Aggravated Possession of Drugs - F5
§2925.11(A), 2925.11(C)(1)(a)

Date of Offense On or about May 31, 2024

Complainant being duly sworn states that Brandon K. Moore, in the City of Celina, Mercer County, Ohio, on or about May 31, 2024, unlawfully

did knowingly obtain, possess, or use a controlled substance or a controlled substance analog and the drug involved in the violation is a compound, mixture, preparation, or substance included in Schedule I or II, to wit: methamphetamine, a schedule II drug.

The offense is contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.

AFFIDAVIT ON COMPLAINT
(O.R.C. 2935.09)

STATE OF OHIO, MERCER COUNTY, SS:

I, do hereby state that I am employed at the Celina Police Department. The following did occur:

On May 31, 2024 I was dispatched to All Seasons Storage, 1045 Elm Street, Celina, Mercer County, Ohio, in reference to a complaint of people living in a storage unit, without consent. Upon arrival, I spoke with Richard Sibert, the manager of the business. He said that he believes that people are living in a storage unit and possibly the car that is parked beside it. I ran the vehicle registration and found that is registered to a Zelda Zizelman, age 73.

While standing outside the unit, I could hear voices coming from inside. Richard and I then opened the unit and observed a male, identified as Brandon Moore, and a female, identified as Shayla Prater.

I told them to get out and Prater walked to the back, to retrieve her cellphone. I told her to get out again. While walking to the back with her I observed what I recognized to be "bongs" and multiple pipes, normally used for drugs of abuse.


After speaking with the Prosecutor, I called Zelda Zizelman, the person who rents the storage unit. I informed her of the complaint and asked her if we could search the storage unit. She said that we could. While searching the unit I collected items that I recognize from my training and experience, to be methamphetamine, and a "bong" that is used to smoke methamphetamine.

Both Brandon Moore and Shayla Prater were taken into custody and drugs of abuse and drug paraphernalia was collected as evidence.
