

STATE OF OHIO, MERCER COUNTY, SS:

I, do hereby state that I am employed at the Mercer County Sheriff's Office. The following did occur:

On September 19, 2024 at approximately 2:39 P.M, Deputy Neiport contacted me and told me that two of the members of the Mercer County Task Force had a residence under surveillance and two wanted persons had went inside and were still there.

I was told that Dustin Abrahamson and Katie Schlarman were inside 121 East Anthony Street, in the City of Celina, Mercer County, Ohio.


Deputies arrived at the home and watched all points of entry and exit. We repeatedly knocked at the doors, calling out for Schlarman and Abrahamson. No one would answer. There was a grey in color, Toyota Corolla parked in the driveway, which is registered to Schlarman.

A female answered the "Ring" doorbell and identified herself as the homeowner, Pennie Harruff. Pennie did not think they would be in the home but said that she would check. After some time, Pennie left work and arrived at the home. We followed Harruff into the home and located a male known to me to be Dustin Abrahamson. He was initially in a bedroom. Abrahamson made comments that we lied and didn't know "they" were there or would have just came in and got them. We asked if Katie Schlarman was there. He said that she was not and was at her father's residence. While Abrahamson was being taken into custody, Deputies announced and ordered Schlarman to come out of the bedroom. She did not. She was then located inside the closet, in the same bedroom Abrahamson was in. Schlarman had multiple warrants for her arrest, both Felony and Misdemeanor.


Both Abrahamson and Schlarman were taken into custody and transported to the Mercer County Detention Facility.
