

did knowingly cause or attempt to cause physical harm to Victim # 1.







AFFIDAVIT ON COMPLAINT
(O.R.C. 2935.09)

STATE OF OHIO, MERCER COUNTY, SS:

I, Haiden Stidam, do hereby state that I am employed at the Mercer County Sheriff's Office. The following did occur:

On January 23, 2025, I was dispatched to the Mercer County Detention Facility to investigate an assault on Correction Officers in the jail. When I arrived, I spoke with Victim # 3 and Victim # 2.


I was told that an inmate, Kristy Baucher was acting erratically and made suicidal comments. Following jail policy, Corrections Officer Heather Leist removed Baucher from her cell and escorted her to the shower area and told her that she would need to change her clothing and put on a smock. Baucher became angry and threatened Leist and told Leist that she would punch her in the face. Baucher balled her hand up in a fist and made a motion towards Leist. Victim # 2 told Baucher she better not do that. Baucher then turned towards Victim # 2 and raised a fist towards her, acting like she was going to punch her. Victim # 2 and Leist grabbed Baucher to escort her to the restraint chair. Baucher continued to yell and resist. Two other Corrections Officers, Deputy Destiny King and Kayla Huebner came to assist. Baucher continued to yell, curse and resist as they tried to restrain her in the chair. Victim # 1 came in to the booking area to assist. When he got close enough, Baucher kicked Victim # 1 in the stomach area. The Corrections staff continued to try and keep her flailing legs and arms constrained as they connected the belts. Baucher kept fighting with them. Baucher threatened Victim # 1 that she would kill him and his family. Baucher then spit on Victim # 1, numerous times, hitting him in the face and head. Victim # 2 covered Boucher's mouth to try and prevent her from emitting bodily fluids. Baucher bit Victim # 2's finger and spit on her also. The restraint chair was wheeled into a holding cell. Once inside, Baucher spit on Victim # 1 again, landing in his left eye.
