*The Jurors of the Grand Jury of the State of Ohio, within and for the body of Mercer County, IN THE NAME AND BY THE AUTHORITY OF THE STATE OF Ohio, do find and present, that Jacob N. Hill, on or about May 5, 2025 in Mercer County, Ohio unlawfully*

did fail to register or send the notice of intent as required, being required to register pursuant to divisions (A) and (B) of this section, and/or being required to send a notice of intent to reside pursuant to division (G) of this section, and the most serious sexually oriented offense or child-victim oriented offense that was the basis of the registration, notice of intent to reside, change of address notification, or address verification requirement that was violated under the prohibition was a felony of the third degree if committed by an adult, to wit: on or about August 28, 2017, in the Court of Common Pleas, Montgomery County, Ohio, Case No. 2017 CR 02129, having been convicted of Gross Sexual Imposition, in violation of R.C. ORC 2907.05.

FURTHERMORE, Jacob N. Hill was previously convicted of or plead guilty to, or previously has been adjudicated a delinquent child for committing, a violation of a prohibition in section 2950.04, 2950.041, 2950.05, or 2950.06 of the Revised Code, to wit: August 3, 2022 in Common Pleas Court, Montgomery County, of ORC 2950.05, Failure to Register, in 2022 CR 01135.






