did knowingly cause or attempt to cause physical harm to Victim # 1, a family or household member.



AFFIDAVIT ON COMPLAINT
(O.R.C. 2935.09)

STATE OF OHIO, MERCER COUNTY, SS:

I, Patrolman Zac Nelson, do hereby state that I am employed at the Celina Police Department. The following did occur:

On September 5, 2025 at approximately 11:23 P.M, Celina Police Department Officers were dispatched to 902 Hemlock Street, in the City of Celina, to investigate a complaint that a female had been assaulted by her boyfriend.

When I arrived, I met with a female who identified herself as Aleena. Aleena said that her mother, Victim # 1 was the victim, and the boyfriend is a Jeffrey Hall. Aleena told us that she was contacted and told about the assault and then drove to 902 Hemlock. Victim # 1 was picked up by someone and left but was on her way back home.


Victim # 1 returned to 902 Hemlock. I could tell, from my training and experience, that Victim # 1 had injuries on her face conducive to an assault. Her right eye was swollen and bruised. Her left eye was also bruised and had some swelling.

Victim # 1 said that her and her boyfriend, Jeffrey Hall, had been to his bosses home. Upon returning home, to 902 Hemlock, they got into argument. The argument then turned violent when Hall struck her in the face multiple times, causing her to fall to the ground. Hall took her phone and left the home. She had to use an "Ipad" to contact someone to come get her.

I photographed Victim # 1's injuries and provided her a written statement form. She said that they both had been consuming alcohol.

I was made aware that Jeffrey Hall had a previous conviction for Domestic Violence, in Celina Municipal Court, Mercer County, Ohio on September 29, 2015 in case number 15CRB00839.

Jeffrey Hall turned himself in to Law Enforcement on Monday September 8, 2025.
