I, Chief Jared L. Laux, do hereby state that I am employed at the Fort Recovery Police Department. The following did occur:

On March 14, 2025, at approximately 7:50 A.M, I was notified by Officer Wyerick that he saw Jeremy Hague in the alley, in the 100 Block of East Broadway Street, in the Village of Fort Recovery, Mercer County, Ohio. I am familiar with Jeremy Hague and was aware that there was a protection order that was issued, saying that Jeremy could not be within 500 feet of Victim # 1, or a place where she might be. Victim # 1 resides at 117 East Brodway Street, Lot number 41.

I responded to that area. While travelling there, I confirmed through the Mercer County Central Dispatch that the protection order was still in place. When I arrived, I found Jeremy. Jeremy admitted that he knew that he wasn't supposed to be there and went on to say that he has been living with Victim # 1, who is the protected person named in the protection order.

I arrested Hague and transported him to the Mercer County Detention Facility. I later researched the distance and found it to be approximately 310 Feet.
