was a parent, guardian, custodian, person having custody or control, or person in loco parentis of a child under eighteen years of age, who did recklessly create a substantial risk to the health or safety of Victim # 1, by violating a duty of care, protection, or support.

FURTHERMORE, the violation resulted in serious physical harm to Victim # 1





AFFIDAVIT ON COMPLAINT
(O.R.C. 2935.09)

STATE OF OHIO, MERCER COUNTY, SS:

I, Det. Douglas Wuebker, do hereby state that I am employed at the Mercer County Sheriff's Office. The following did occur:


On March 20, 2025, I was provided with information that a two-year-old child had been admitted to the Dayton Children's Hospital, due to ingesting a THC product. I was told that Mercer County Children's Services was involved. The information we had at the time of the report was that the child ingested a THC product at her home, located at 3601 State Route 703, Lot # 21, in Celina, Mercer County, Ohio. The parents noticed the child being lethargic and unresponsive. The child was taken to Joint Township Hospital in St. Mary's, Ohio then transferred to Dayton Children's.

Det. Carla Baucher and I went to Dayton Children's Hospital to speak with the parents of the child, victim # 1. Once there, we found that victim # 1's status had been downgraded from intensive care and was moved to a regular room. We separated and spoke with the parents. I spoke with the father, Dustin Wyatt and Baucher spoke with the mother, Megan Wyatt.

Dustin said that he went to work at around 4:00 A.M., on the morning of March 19, 2025. He returned home around 4:00 P.M. When he got home, victim # 1 was sleeping on Megan's chest. They woke her up around 5:00 P.M., to eat. She ate a little bit, then slumped over. Both parents took turns holding her. After some time, she was not getting any better. When she couldn't keep her eyes open any more, they took her to the hospital. At around 10:30 to 11:00 P.M., Dayton Children's Hospital transported victim # 1 to Dayton. When they arrived in Dayton, further testing was done and found that victim # 1 had tested positive for THC. He said that he and his wife both use recreational marijuana, including waxes and edibles. He said that these items are normally locked away, but he said that Megan admitted to him that she left some edibles out on a table. He described the chocolates that Megan eats as like "Reese's" peanut butter cups and pieces in a bag and squares that come in a bag.

Detective Baucher interviewed the mother, Megan Wyatt. Megan said that she thinks that victim # 1 had gotten into her edibles while she was in the restroom for about fifteen minutes, because she was on the phone, changing her underwear, and doing 50 million things. Megan recounted the same events as Dustin. She said that after eating some eggs, victim # 1 fell asleep and they had a hard time waking her up. She told Dustin something was wrong and went to the hospital. Megan confirmed that both her and Dustin both use THC products. She said that they do not have a medical marijuana card. Megan said that they put stuff in a box

and sometimes on a table, or TV tray. She said that this day, she had a bong and chocolate edibles that resembled "Resse's" peanut butter cups. She said that those items would still be on the table as they left the house in a hurry to get victim # 1 treatment. Megan said that there is a second child in the home, victim # 2. A third child visits periodically but hasn't been there for a couple of weeks.


I told Megan that the Sheriff's Office was conducting a search of home, as we were speaking. Megan was now saying that the edibles wouldn't be on the table anymore because they did take the time to clean some of it up, prior to seeking medical attention for victim # 1. She put the chocolates in a bag and threw them on the couch.

When asked where her and Dustin obtain the THC products, Megan said from a ^{dispensary} ~~distillery~~ in Wapakoneta, Ohio.

While we were in Dayton speaking with the Wyatts, the Mercer County Sheriff's Office and the Grand Lake Task Force obtained a search warrant and searched the Wyatt property located at 3601 State Route 703, Lot # 21. Officers conducting the search found the home in a deplorable condition. The home was in complete disarray. There was trash strewn about the home. None of the mattresses had any coverings. There were no blankets or pillows on the beds. There was a foul odor and bugs flying around. In the living room, officers located a table with multiple marijuana bongs and a propane torch on it and marijuana products laying out in the open. A bag of numerous marijuana-containing edibles was found on a couch. A package labelled, "Barracuda Cannabis Cups, 200 mg THC, milk chocolate peanut butter, Detroit Edibles" was found in a trash can, next to the front door, outside the residence. Officers also found receipts for marijuana-containing edibles from a dispensary in Monroe, Michigan, which contradicted Megan's claims that they purchased the items from a dispensary in Wapakoneta.


All the THC items and paraphernalia were seized.


