The offense is contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.



AFFIDAVIT ON COMPLAINT
(O.R.C. 2935.09)

STATE OF OHIO, MERCER COUNTY, SS:

I, Hannah Oakley, do hereby state that I am employed at the Mercer County Sheriff's Office. The following did occur:

On September 20, 2025, at approximately 8:05 A.M, I was dispatched by Mercer County Central Dispatch, to the intersection of Burketsville-Saint Henry Road and Watkins Road, Mercer County, Ohio.

When I arrived, I saw a car, impaled underneath the Southernmost part of a trailer attached to a 2022 Volvo 760. Emergency personnel were already on scene and was working on extracting the sole occupant, the driver, out of the white 2020 Hyundai Sonata. The driver of the semi was out of his vehicle and walking around. He was identified as Amrinder Singh, date of birth, 11/25/1994. The driver of the other car that collided with the semi was identified as Victim # 1.

Singh initially said that he was travelling Southbound on Burketsville-Saint Henry Road and the car was travelling Eastbound on Watkins Road. He said that he doesn't think that she stopped at the stop sign and collided with him. Later, Singh changed his statement and said that he was travelling Eastbound on Watkins Road and thought it was a four-way stop. He said that he stopped, pulled into the intersection, and the white car collided with him.

After doing a review of the scene, it was determined that the Volvo, operated by Singh, was Eastbound on Watkins Road and Victim # 1 was Northbound on Burketsville-Saint Henry Road. It was determined that the Volvo did not stop at the posted stop sign on Watkins Road due to the final resting point, compared to the point of impact.

Victim # 1 was removed from the car and transported to Mercer Health Hospital. She was then transported to Miami Valley Hospital. Singh agreed to voluntarily provided a blood and urine sample, for analysis. I transported him to Mercer Health to get that completed.


