STATE OF OHIO, MERCER COUNTY, SS:

I, Quintin Thomas, do hereby state that I am employed at the Mercer County Sheriff's Office. The following did occur:

On October 22, 2025, at approximately 1:48 P.M, I was dispatched to the intersection of Saint Peters Road and Fox Road, in Mercer County, Ohio to investigate a complaint of a female passed out behind the wheel of a motor vehicle. I was told that she was passed out behind the wheel, sitting at the stop sign and that there was also a child inside the car.

When I arrived, Fort Recovery Police Chief Jared Laux was already on scene. Laux told me that the female driver seemed impaired. I also noticed three other people. These were three citizens who stopped because they saw the female and was concerned. I was told that the child that was in the car had been moved to one of the witness's vehicles.

Sgt. Rachel Heinl arrived on scene, and I witnessed Heinl speaking with the female driver, who was identified to be a Lori A. Schmackers, date of birth 03/14/1982. While speaking with Schmackers, she was very disoriented, her eyes were bloodshot and glassy. Schmackers speech was slurred and her head kept nodding. When asked, Schmackers said that she didn't know where she was.

I asked Schmackers to step out of the vehicle which she complied. I asked her to submit to standard field sobriety tests. After the standard field sobriety tests were completed, I placed Lori under arrest for operating a vehicle under the influence of alcohol or drugs or both.

The child was identified as Victim # 1, date of birth 12/15/2022. The father of the child was contacted to take custody of the child.

I transported Schmackers to the Mercer County Detention Facility. Once there, I read her Miranda and read and showed her the BMV form 2255. When I asked her to submit to a BAC test, she refused. Schmackers was incarcerated into the Mercer County Detention Facility.

I determined that Schmackers had a prior OVI in 2019. She was previously convicted of OVI on December 4, 2019, in Celina Municipal Court in case number TRC009109. Schmackers also has a previous conviction for Endangering Children, in Celina Municipal Court case number CRB1900214. That conviction date was also on December 4, 2019.
