COUNT XXIV - GROSS SEXUAL IMPOSITION - O.R.C. Section 2907.05(A)(4) - F-3

On or about July or August, 2024, did in this County violate Ohio Revised Code Section 2907.05(A)(4) in that she did cause two or more other persons to have sexual contact when the other person, or one of the other persons, was less than thirteen (13) years of age, whether or not she knew the age of the person, to wit: she encouraged, coaxed and observed a child under the age of two (2) years engage in sexual contact with another specifically for the purpose of sexually arousing herself or the child, being a felony of the third degree.
