AFFIDAVIT ON COMPLAINT
(O.R.C. 2935.09)

STATE OF OHIO, MERCER COUNTY, SS:

I, Colin Fuelling, do hereby state that I am employed at the Celina Police Department. The following did occur:

On November 3, 2024 at approximately 9:07 AM, I arrived at the Emergency Room at Mercer Health Hospital in Coldwater, Ohio after receiving a phone call from an ER nurse regarding a possible domestic violence victim that was a patient in the ER.

I entered the patient room and observed Victim #1 holding gauze to her chin. I observed blood on the front part of the collar of her sweatshirt. I asked Victim #1 what had happened to her. She advised that her and her boyfriend, Aaren Toth, had gone out for a drink the night prior. She said that they each had only one drink, then went home. Victim #1 stated that Aaren was acting like something was bothering him but would not talk to her or tell her what was wrong. She stated this upset her as she likes to have open communication with him.

Victim #1 stated that they both went to bed, and she woke up around 5:00 AM to use the restroom. Victim #1 said that Aaren was playing a video game, and she told him she loved him. She stated that Aaren gave her a thumbs up but did not say anything or look at her. She went over to him and asked him what was wrong and told him to talk to her. Victim #1 stated that Aaren then got mad and, all of a sudden, bit her on the chin. Victim #1 asked Aaren what he had just done, and he responded that he didn't know, and claimed that he had blacked out.

I then asked Victim #1 if I could see her wound. She removed the gauze. I observed that the bite was perpendicular to her face (sideways bite). I observed a larger open laceration to the left side of her chin that was approximately a half inch wide and two inches long. This appeared to be where Aaren's top teeth had penetrated her chin. On the right side of her chin, I observed a smaller laceration that was approximately one quarter inch wide and a little under two inches long. This appeared to be where Aaren's bottom teeth had penetrated her chin. I then took pictures of Victim #1's injuries.

After leaving the hospital, I spoke with Victim #1 on the phone. She advised that she had gotten approximately 30 stitches in her chin and a tetanus shot.

Later in the shift, I spoke with Aaren in person. I asked Aaren to tell me what happened. He said that he and Victim #1 had gotten into an argument and that he had bit her. Aaren stated he didn't know why, but he bit her. He claimed that Victim #1 had set him off

and he blacked out. I explained to Aaren that he should not have contact with Victim #1 and referred the matter to the Prosecutor's Office.
