Date of Offense On or about January 17, 2025

Complainant being duly sworn states that Douglas E. Miller, Jr., in Mercer County, Ohio, on or about January 17, 2025, unlawfully did knowingly cause or attempt to cause physical harm to Victim # 1, a family or household member.

FURTHERMORE, Douglas E. Miller, Jr. has previously pleaded guilty to or been convicted of domestic violence, a violation of an existing or former municipal ordinance or law of this or any other state or the United States that is substantially similar to domestic violence, a violation of section 2903.14, 2909.06, 2909.07, 2911.12, 2911.211, or 2919.22 of the Revised Code or any offense of violence if the victim of the violation was a family or household member at the time of the commission of the offense, to wit: June 6, 2022 in Celina Municipal Court, Mercer County, Ohio, of ORC 2919.25A, Domestic Violence, in case number 22CRB00242

The offense is contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.

AFFIDAVIT ON COMPLAINT
(O.R.C. 2935.09)

STATE OF OHIO, MERCER COUNTY, SS:

I, Christopher Hamberg, do hereby state that I am employed at the Mercer County Sheriff's Office. The following did occur:

On February 21, 2025 the Mercer County Sheriff's Office was notified of a domestic violence complaint. The complaint involved a ten-year-old female that lived with her mother and mother's fiancé at 10529 Celina Mendon Road, Mendon, Mercer County, Ohio. The suspect was reported to be the fiancé, Douglas E. Miller, Jr.

In an interview with victim # 1, she said that on February 17, 2025, there was no school and she was home. She wanted to go to her fathers for the day and Miller refused. She was walking away from Miller, and he grabbed the hood on her jacket and pulled her backwards, which caused her to fall. Victim # 1 said that she felt she was being choked while being dragged. Miller grabbed her, flipped her over and spanked her on the buttocks several times, with an open hand. She was screaming and yelling and Miller then flipped her back over and punched her on the left side bottom part of her jaw. Deputies were able to see a visible bruise on her jaw, in the area she said that she was struck.


Deputies Stidham and Huber interviewed the suspect Miller. Miller said that he only hit her once and it was with one finger. He said that it was because she was back talking him. He did admit to pulling her hood and dragging her and spanking her on the buttocks.

Miller was placed under arrest for domestic violence and transported to the Mercer County Detention Facility.

We later determined that Miller was previously convicted of Domestic Violence in Celina Municipal Court on June 6, 2022.


