The offense is contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.





AFFIDAVIT ON COMPLAINT
(O.R.C. 2935.09)

STATE OF OHIO, MERCER COUNTY, SS:

I, Detective Douglas Wuebker, do hereby state that I am employed at the Mercer County Sheriff's Office. The following did occur:

On August 21, 2024, Detective Chad Fortkamp received an email from the Internet Crimes Against Children office, based out of Cuyahoga County, Ohio and commonly called ICAC. The email tip reported that ICAC had discovered that a person from Mercer County, Ohio had been receiving or exchanging sexual images or performances involving a juvenile or juveniles.

The email identified the person as being a Brian J Evers and mentioned that Evers has a daughter, that appears to be about the same age as the participant in the images. The emails mentioned the Internet Protocol(IP) addresses used. The IP addresses used all have the same subscriber as Evers and the platform used was the KIK platform. The address of the subscriber is 3037 Stelzer Road, Celina, Ohio 45822, which is Evers address.

There were numerous Tip line reports, the first one was dated July 28, 2024. The last one being August 21, 2024. Each tip describes different images and videos of juvenile females engaging in different sexual performances.

On August 22, 2024 I applied for and was granted a search warrant for the address of 3037 Stelzer Road, Celina, Ohio. The search was conducted and several cell phones and other electronics were seized. The cell phones were forensically examined and nothing of concern was located.

On September 25, 2024, Brian Evers voluntarily came to the Mercer County Sheriff's Office at my request. I explained to Brian that he came freely and was free to leave any time that he wanted. He understood that. Brian admitted to the violations we talked about. Evers said that he solely used his cell phone and no other devices. He said that he used the KIK application and would go into an area of KIK called "role play." On this site, he would start conversations and those conversations may turn sexual in nature. Evers said that he wanted these conversations to be sexual to fulfill his sexual desire, which is why he was there. Brian admitted to receiving and sending out pornography that involved juveniles that were infant, toddler, school age to adolescent in age.

I went through the eight cyber tips that we had received and Evers admitted to each one being his display names and being a participant.
