MEMORANDUM

On January 24, 2025, Defendant Trey Frech entered pleas of Guilty to one count of Aggravated Vehicular Homicide in violation of R.C. 2903.06(A)(2)(a), a Felony of the Third Degree, and three counts of Vehicular Assault in violation of R.C. 2903.08(A)(2)(b), each being a Felony of the Fourth Degree. The incident leading to the instant case occurred at dusk on December 22, 2023 and involved Defendant's car colliding with a horse-drawn buggy on State Route 49 as Defendant was attempting to pass another vehicle. Tragically, one of the occupants of the buggy was killed and three others sustained injuries. Defendant was transported to Lutheran Hospital via Care Flight due to his injuries. Investigation by the Mercer County Sheriff's Office revealed that Defendant's alcohol use was a factor in the crash. Defendant was originally indicted for offenses relating to both impaired driving and reckless driving, however discussions and negotiations during the pretrial process led to the State of Ohio agreeing to dismiss the impaired driving charges in exchange for Defendant pleading quilty to charges relating to reckless driving.

A court that sentences an offender for a felony shall be guided by the overriding purposes of felony sentencing. The overriding purposes of felony sentencing are to protect the public from future crime by the offender and others, to punish the offender, and to promote the effective rehabilitation of the offender using the minimum sanctions that the court determines accomplish those purposes without imposing an unnecessary burden on state or local government resources. To achieve those purposes, the sentencing court shall consider the need for incapacitating the offender, deterring the offender and others from future crime, rehabilitating the offender, and making restitution to the victim of the offense, the public, or both.

R.C. 2929.11(A). The Court has discretion as to how to comply with the overriding purposes of felony sentencing, however the Court shall consider the seriousness and recidivism factors contained in R.C. 2929.12(B)-(E). R.C. 2929.12(A). R.C. 2929.12(B)-(E) read as follows:

(B) The sentencing court shall consider all of the following that apply regarding the offender, the offense, or the victim, and any other relevant factors, as indicating that the offender's conduct is more serious than conduct normally constituting the offense:

(1) The physical or mental injury suffered by the victim of the offense due to the conduct of the offender was exacerbated because of the physical or mental condition or age of the victim.

(2) The victim of the offense suffered serious physical, psychological, or economic harm as a result of the offense.

(3) The offender held a public office or position of trust in the community, and the offense related to that office or position.

(4) The offender's occupation, elected office, or profession obliged the offender to prevent the offense or bring others committing it to justice.

(5) The offender's professional reputation or occupation, elected office, or profession was used to facilitate the offense or is likely to influence the future conduct of others.

(6) The offender's relationship with the victim facilitated the offense.

(7) The offender committed the offense for hire or as a part of an organized criminal activity.

(8) In committing the offense, the offender was motivated by prejudice based on race, ethnic background, gender, sexual orientation, or religion.

(9) If the offense is a violation of section <u>2919.25</u> or a violation of section <u>2903.11</u>, <u>2903.12</u>, or <u>2903.13</u> of the Revised Code involving a person who was a family or household member at the time of the violation, the offender committed the offense in the vicinity of one or more children who are not victims of the offense, and the offender or the victim of the offense is a parent, guardian, custodian, or person in loco parentis of one or more of those children.

(C) The sentencing court shall consider all of the following that apply regarding the offender, the offense, or the victim, and any other relevant factors, as indicating that the offender's conduct is less serious than conduct normally constituting the offense:

(1) The victim induced or facilitated the offense.

(2) In committing the offense, the offender acted under strong provocation.

(3) In committing the offense, the offender did not cause or expect to Cause PM physical harm to any person or property.

(4) There are substantial grounds to mitigate the offender's conduct, although the grounds are not enough to constitute a defense.

(D) The sentencing court shall consider all of the following that apply regarding the offender, and any other relevant factors, as factors indicating that the offender is likely to commit future crimes:

(1) At the time of committing the offense, the offender was under release from confinement before trial or sentencing; was under a sanction imposed pursuant to section 2929.16, 2929.17, or 2929.18 of the Revised Code; was under post-release control pursuant to section 2967.28 or any other provision of the Revised Code for an earlier offense or had been unfavorably terminated from post-release control for a prior offense pursuant to division (B) of section 2967.16 or section 2929.141 of the Revised Code; was under transitional control in connection with a prior offense; or had absconded from the offender's approved community placement resulting in the offender's removal from the transitional control program under section 2967.26 of the Revised Code.

(2) The offender previously was adjudicated a delinquent child pursuant to Chapter 2151. of the Revised Code prior to January 1, 2002, or pursuant to Chapter 2152. of the Revised Code, or the offender has a history of criminal convictions.

(3) The offender has not been rehabilitated to a satisfactory degree after previously being adjudicated a delinquent child pursuant to Chapter 2151. of the Revised Code prior to January 1, 2002, or pursuant to Chapter 2152. of the Revised Code, or the offender has not responded favorably to sanctions previously imposed for criminal convictions.

(4) The offender has demonstrated a pattern of drug or alcohol abuse that is related to the offense, and the offender refuses to acknowledge that the offender has demonstrated that pattern, or the offender refuses treatment for the drug or alcohol abuse.

(5) The offender shows no genuine remorse for the offense.

(E) The sentencing court shall consider all of the following that apply regarding the offender, and any other relevant factors, as factors indicating that the offender is not likely to commit future crimes:

(1) Prior to committing the offense, the offender had not been adjudicated a delinquent child.

(2) Prior to committing the offense, the offender had not been convicted of or pleaded guilty to a criminal offense.

(3) Prior to committing the offense, the offender had led a law-abiding life for a significant number of years.

(4) The offense was committed under circumstances not likely to recur.

(5) The offender shows genuine remorse for the offense.

The Court may consider any other factor relevant to achieving the purposes and principles of sentencing. R.C. 2929.12(A).

Defendant acknowledges the great harm that was caused as a result of the commission of the offenses. One victim lost her life and three others suffered significant physical harm. Defendant in no way intends to minimize the harm suffered by the victims as a result of the offenses. Defendant would note, however, the harm suffered by the victims is only one of many factors this Court should consider. In fact, it is the only factor of the nine enumerated under R.C. 2929.12(B) that would indicate Defendant's conduct to be more serious than conduct normally constituting the offense. Defendant asserts he did not intend or expect to cause physical harm to persons or property, which is a factor suggesting the offense is "less serious" pursuant to R.C. 2929.12(C)(3). As such, seriousness factors are balanced.

Regarding recidivism, all enumerated factors under R.C. 2929.12(D) and (E) show Defendant is not likely to commit future crimes. Defendant has no prior criminal history. While alcohol was involved in the commission of the offense, Defendant has neither demonstrated a pattern of criminal offenses related to alcohol abuse nor refused treatment. To the contrary, Defendant began seeing a psychotherapist shortly before the incident and has continued attending counseling services for over a year. Defendant also quit drinking and has maintained sobriety for a significant period of time. A Treatment Summary from Michelle Phillips is attached hereto and incorporated by reference as Exhibit A. Defendant's proactive approach to seeking mental health and substance^{11,12,2025 01:39 PM} counseling before the offense occurred, as well as his dedication to continued counseling services after the incident, demonstrate that Defendant is amenable to rehabilitation. Defendant's actions after the incident, including his compliance with pretrial supervision, support the position that he is unlikely to commit future crimes. The incident, while preventable, was still an accident. Defendant poses no greater risk to the public than any other member of society. Finally, Defendant has expressed great remorse for his actions. In further support, Defendant submits herewith and incorporates by reference Eighteen (18) letters from family, friends, and community members in support of Defendant as Exhibits B through S.

In conclusion, Defendant appreciates the serious harm suffered by the victims. Defendant understands the necessity of a punishment and the Court's duty to impose a just sentence. Nevertheless, Defendant asserts the statutory seriousness factors are balanced and the recidivism factors support a more-lenient sentence. As evidenced by the character letters in Defendant's support, he clearly is valued in the community and will have a strong support system to ensure his continued compliance with this Court's sentence and the laws of the State of Ohio. Defendant therefore requests that any term of incarceration imposed by this Court be a **total aggregated sentence of less than Five (5) Years** in order to permit Defendant to petition this Court for judicial release prior to serving four years, which would be the earliest eligibility date should this Court order a sentence of five years or more. Defendant notes that a prison term is not mandatory and Defendant is eligible for a community control sanction. In the event this Court finds community control would demean the seriousness of the offense, a lengthy prison term would not be necessary when considering the overriding purposes of felony sentencing and the seriousness and

recidivism factors.

WHEREFORE Defendant respectfully requests this Court order an aggregate term of incarceration of less than Five (5) Years along with whatever fines and driver's license suspension this Court deems appropriate.

familial relationships and romantic relationships. The difficulty with communication prior to treatment contributed to his maladaptive use of alcohol.

Interventions Used:

- Motivational interviewing.
- Exploration of coping patterns, emotions, and relationship patterns.
- Psychoeducation.
- Cognitive restructuring.
- Mindfulness and urge surfing.
- Grief and loss work.
- Cognitive processing therapy (CPT).
- Imaginal exposure.
- Somatic experiencing.
- Self-monitoring techniques.
- Communication skills training.
- Relaxation/deep breathing exercises.
- Structured problem-solving.
- Supportive reflection.
- Symptom management.

Progress and Outcomes:

- The client made progress by acknowledging his alcohol use problem and showing willingness to reduce his alcohol consumption. He is currently sober and reports minimal urges to drink.
- He was able to identify triggers and patterns of alcohol use.
- Showed improvement in communication skills and was receptive to learning urge surfing techniques.
- Developed coping strategies for managing stress and negative emotions.
- Expressed remorse for his actions and engaged in therapy sessions actively.
- Maintained sobriety for a period and reported decreased alcohol intake prior to ceasing use.

Recommendations:

- Continue individual therapy sessions to address underlying psychological factors contributing to his substance use disorder.
- Continue exploring triggers and patterns of alcohol use and anger.
- Develop and practice new coping skills for managing negative emotions.
- Create a relapse prevention plan.

My name is Lee A. Morris and I serve as the junior high/high school principal for Tri-Village Local Schools in New Madison, OH, a position I have held since August 2013. Mr. Trey James Frech is a 2018 graduate of Tri-Village Local Schools. Trey graduated with a 3.056 grade point average, having earned 31.25 credits, 7.25 credits more than the district required 24. Over the course of his high school career, Trey missed just 14.5 days of school in his four years as a Patriot. Trey earned proficient scores or better on all of his End of Course assessments, in the areas of Algebra I, English 9, Biology, English 10, Geometry, American History, Physical Science, and American Government.

Trey was a classic small town student and athlete during his time at Tri-Village. Participating in activities such as Cross Country (1 year), Football (3), Basketball (4), Baseball (4), Peer Tutoring (2), Student Council (4), Choir (2), Trey was a student during the hours of 8am until 245pm each day, however his presence in the above-mentioned activities made him a constant cog in the wheel of our school district. Trey's peers voted him in their annual "Senior Superlatives" as having the "Best Smile," being the "Teacher's Pet," "Best Dressed," and "Most Dramatic."

I have had the pleasure of working alongside Trey and his parents, Jim and Tracy, multiple times on behalf of the New Madison Kiwanis at the annual Great Darke County Fair. His mother Tracy is currently in her second stint as a member of the Tri-Village Local Board of Education, where our teamwork continues to this day. Small town connections historically run very deep, with relationships intertwining in a myriad of ways. There was an almost six year period where it crossed my mind that Trey would perhaps one day be my son-in-law.

Trey and my eldest daughter, Edie, were high school "sweethearts" beginning his sophomore year and continued their relationship for the next six years roughly, until her college/career path led her out of state to Kentucky and his career path kept him close to home with friends, family, and land. Trey's family has been part of the greater New Madison community for several generations, and family roots grow deep in both Darke and Mercer Counties. I would venture to say that there was a part of Trey that considered uprooting himself and following my daughter to

Lexington and beyond, but in the end, some roots are too strong to separate from the soil in which they are bound. They grew apart due to no fault of either party; life happens.

Trey vacationed with our family many times, worked with me on projects around the house, cared for our dogs, and displayed many traits that would make him an ideal partner for one's daughter. He showed on many occasions that he was trustworthy, caring, and dependable. I went for a significant period following their break up where I didn't see or hear from Trey for reasons both obvious and unknown, but he and I did catch up one day over coffee after he reached out asking to talk. I was happy to sit down and catch up, and told him that I missed seeing him at our home sporting events. A short time later, he came to one of our home girls basketball games and we again had a great talk. These are some instances where just he and I were able to discuss life, struggles, and the hassles of adult life, much different than our previous talks during our principal/student years. I always remember Trey very fondly and continue to do so to this day.

When sitting down to pen this letter, I visited our school library and grabbed the 2018 school yearbook, titled "Our Journey," and realized immediately that I didn't really need to thumb through the pages in order to tell what brought Trey and I together. Knowing that I would find the information I thought I was looking for, like activities, sports, senior superlatives, I expected to find the expected. I flipped the pages until I was able to obtain the things I thought I was looking for. But as yearbooks can sometimes do, it led me down the rabbit hole of 2018 that I wasn't expecting to find, one that I'm sure I had never seen before. On page 72, under the caption "Blood Drive," was a picture of Trey Frech, laying on a makeshift table in our auditorium, smiling while donating a pint of blood to the Community Blood Center. Giving life.

Your honor, giving life is the opposite of what brings you and these pages together. But giving life was in Trey in 2018, and I believe that it is still within him today in 2025. His situation is gut-wrenching, and the decision that you will make to dispense justice in this matter is one that weighs heavily on you, both personally and professionally I am sure. The gravity of Trey's situation weighs heavily on all parties involved.

I appreciate you taking the time to read this correspondence. God bless you as you move forward.





My name is Hillarie Frech, and I am Trey's sister. I have had the pleasure and privilege of knowing my brother for 25 years, both as a sibling and a close confidant. Throughout our lives, Trey has consistently demonstrated qualities such as honesty, integrity, responsibility, being a hard worker, and reliability. There are so many examples that I could provide to you to show these attributes, but one instance really stands out to me that can show you all of them at once.

About 5 years ago I was personally going through a rough time as to where I was in criminal trouble as well and even had been in a car accident. I was 28 years old and was having to move back in with my parents, my boyfriend was being sent to prison, and I felt like I was a complete failure at everything. One person who really stepped up and helped me get through this hard time was Trey. He would talk to me when I needed someone to talk to, he would drive me places if I needed to go somewhere, whatever it may have been, he was there to help me out. I full-heartedly believe that Trey learned from this low point in my life, how to get through his own low point. He was able to put the shoe on the other foot, per se, and has been able to use the resources around him and get himself back on the right track. I think that in continuing this journey to improve himself and stay out of trouble, he needs to be around his family, friends, and other confidants that he has in his life. Being sent away from all the positivity he has is not going to do him any good at this point in his life. All I am asking for, for Trey, is to at least give him the chance to keep making strides in the right direction.

With all this said, I do realize and acknowledge that Trey has broken the law and that there are consequences for the actions he has taken. However, I do not believe that sentencing Trey to community control would demean the seriousness of the offense. The initiative of being sent to prison is to rehabilitate an offender by addressing the root causes of why the crime was committed and to set them up for success for when they get back out into society and decreasing the recidivism factor so they will not commit the crimes again. Since the accident occurred, Trey was never arrested or put into custody. He was able to continue to be out and prove to everyone, as well as himself, that he is able to change and keep moving forward rather than putting his life on hold by being behind a cell door. He has continued to work and rise in the ranks within his electrical job. He has also managed to stay out of trouble and abide by the conditions that were set forth for him by the pre-sentencing probation department. Personally, I just feel that sentencing Trey to a prison term would not be beneficial or productive for him. He is going in the right direction currently, with his career, building a little family of his own, and continuing to be involved in all his family's lives and be a role model for his two nephews. If

sending someone to prison is to punish them while helping them become better people, then I believe that this can effectively happen while being outside the prison system and having the probation department as well as his family continue to hold him accountable and keep him on the right path, thus reducing the likeliness of recidivism.


