did knowingly use, or possess with purpose to use, drug paraphernalia.



**AFFIDAVIT ON COMPLAINT**  
**(O.R.C. 2935.09)**

STATE OF OHIO, MERCER COUNTY, SS:

I, Ptl. Zac Nelson do hereby state that I am employed at the Celina Police Department. The following did occur:

On October 17, 2024, at approximately 9:44 P.M, I saw a black Dodge sedan style vehicle travelling Eastbound on West Logan Street, in the City of Celina, Mercer County, Ohio. As I was looking at the vehicle, I noticed several cracks in the windshield, one of which ran the entire width of the windshield. I initiated a traffic stop on the vehicle.

I contacted the driver. There were two occupants. The driver was identified as a Brian Dull and the front seat passenger was identified as Donald Heath. Dull admitted that he didn't have a valid driver's license. Dispatch told me that through a LEADS check, that he was also under a 12-point suspension. The passenger, Heath, appeared to be trying to hide something in his jacket pocket.

I requested a K9 be brought to my location. Sgt. Bartlett, also of the Celina Police Department, brought his dog to my traffic stop. The dog performed a free air sniff around the motor vehicle. Bartlett told me that the K9 alerted to the presence of narcotics.

Both males were removed from the car and their persons were checked. Nothing was located on them. Officers then searched the car. Ptl. Kerr located a baggie of a crystal-like substance on the passenger side floorboard. There was also a plastic container that had a crystal-like residue. From my training and experience, this substance appeared to be methamphetamine. On the driver's side floor, I found a straw that contained more of the crystal like residue.

Both males were mirandized and asked about the items that we located. Both denied knowledge of the items.

Both males were taken into custody and transported to the Mercer County Detention facility.
