Complainant being duly sworn states that Jason R. Stein, in Mercer County, Ohio, on or about May 8, 2025, unlawfully

did knowingly cause or attempt to cause physical harm to Victim # 1, a family or household member.

FURTHERMORE, Jason R. Stein has previously pleaded guilty to or been convicted of three offenses of domestic violence or violations of section 2903.14, 2909.06, 2909.07, 2911.12, 2911.211, or 2919.22 of the Revised Code or any offense of violence involving victims who were family or household members at the time of the commission of the offenses, to wit: October 24, 2011 in Celina Municipal Court, Mercer County, Ohio, of ORC 2919.25A, Domestic Violence, in case number CRB1101050 and July 27, 2012 in Celina Municipal Court, Mercer County, Ohio, of ORC 2919.25A, Domestic Violence, in case number CRB1200539 and September 22, 2014 in Celina Municipal Court, Mercer County, Ohio, of ORC 2919.25A, Domestic Violence, in case number **CRB 1400852 A.**

The offense is contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.

AFFIDAVIT ON COMPLAINT
(O.R.C. 2935.09)

STATE OF OHIO, MERCER COUNTY, SS:

I, Deputy Jacob Huber, do hereby state that I am employed at the Mercer County Sheriff's Office. The following did occur:

On May 8, 2025, at approximately 7:23 A.M, Mercer County Sheriff's Office Deputies were dispatched to 7239 Riley Road, to investigate a complaint of domestic violence. Dispatch relayed to us that Victim # 1 called and said that he was assaulted by his son, Jason Stein.

I arrived at the residence and spoke with Victim # 1. He looked like he had been in a confrontation. He had red marks on his face and was covered in saw dust and dirt. Victim # 1 said that he was in his barn, when Jason texted him asking to use his mower. Victim # 1 told him no. Jason then walked out to the barn and when again was told no, got angry, and started breaking items. Victim # 1 got up and went out into a shop area away from Jason. Jason followed, still agitated. He got "in his face" and was spitting. Victim # 1 extended his arms to move Jason back. When he was in his face, Victim # 1 could smell alcohol on Jason's breath. After being pushed back, Jason struck Victim # 1 in the face. Jason then got Victim # 1 on the ground. Victim # 1 tried to fight back by kicking and trying to get Jason off of him, but Jason continued to punch and hit Victim # 1. Victim # 1's glasses got knocked off of his face in the scuffle.

I then went into the residence and spoke with Jason Stein. Jason gave the same account of events, up until the point of being in the barn. He said that Victim # 1 kicked him first, starting the scuffle. I didn't see any signs of violence on Jason, other than some blood on his knuckles.

Sgt. Forsthoefel placed Jason under arrest and transported him to the Mercer County Detention Facility. Once at the jail, Jason submitted to a PBT and tested a .224 B.A.C. level.


Upon review of Jason's Computerized Criminal History Report, I discovered that Jason has three prior domestic violence convictions: (1) October 24, 2011 in Celina Municipal Court, Mercer County, OH, ORC 2919.25(A): Domestic Violence, in Case No. CRB1101050; (2) July 27, 2012 in Celina Municipal Court, Mercer County, OH, ORC 2919.25(A): Domestic Violence, in Case No. CRB1200539; and (3) September 22, 2014 in Celina Municipal Court, Mercer County OH, ORC 2919.25(A): Domestic Violence, in Case No. CRB1400852A.


