Complainant, being duly sworn, states that NICHOLAS J MANTIA on or about August 2nd, 2024 in Mercer County, Ohio, did No person shall knowingly cause or attempt to cause physical harm to a family or household member. TO WIT: Nicholas Mantia did slap [REDACTED] referred to herein as Victim #1, in the jaw on the right side of her face with an open hand while "reprimanding" her for having pinched him on the back of the neck. Victim #1 alleged that she "blacked out," but remained upright after this slap occurred. Victim #1 experienced bleeding and soreness in the jaw and mouth area, which she alleged was caused by Nicholas' actions. This is contrary to and in violation of Ohio Revised Code section § 2919.25(A), titled Domestic Violence, a Misdemeanor of the First Degree.
