did with purpose to deprive the owner, Victim # 1, of property or services, to wit: \$7,658.32, knowingly obtain or exert control over either the property or services without the consent of the owner or person authorized to give consent.

FURTHERMORE, the victim of the offense is an elderly person and the property or services stolen is valued at seven thousand five hundred dollars or more and less than thirty-seven thousand five hundred dollars.




